1. Events will begin at 9:00 am.
2. Events include: Putting the Stone 20#, 56# Weight Throw, 28# Weight Throw, 22# Hammer Throw, Caber Toss, 20# Sheaf Toss, 56# Weight Toss. *Time permitting: Braemar Stone and Light Hammer.
3. Each athlete may set up one 12x12 tent. Set-up required between 7:00-9:00 am. Tents must stay erected until 5:00 pm. Tents must be anchored or staked. Please leave your space as you found it, free of trash and debris.
4. **Outside alcoholic beverages are not permitted.** Beverages will be sold on the festival grounds.
5. Athletes are invited to participate in the walking parade followed by the Opening Ceremony.

General Release and Indemnification:

By signing this document, I acknowledge receiving the contract for the Irish Fest Camden heavy events, hereinafter known as "EVENT", reading the regulations, understanding its contents, how they will apply, and agree to fully comply.
